3. The Collier County Parks & Recreation Department is not responsible for attendance, sales or closure due to regulatory or licensing agencies.
4. Collier County Parks & Recreation reserves the rights to deny, reject, or remove any exhibitor found to be in violation of the guidelines or County policies or ordinances.
5. **Vendor will be immediately removed from park and never allowed to return if found to be displaying or selling any products connected with the tobacco industry or viewed as drug paraphernalia.**
6. Vendor will be immediately removed from Park and never allowed to return if found to be displaying or selling any products that may appear to look like or be utilized as a weapon.
7. Vendors must arrive for setup at Golden Gate Community Center on Friday between 9a.m. and 4p.m. Vendor's parking passes will be given out at the time of the vendor's arrival to the park, not on the day of the event.
8. Vehicles must be removed from the event area by 2:00 pm (other than self-contained vendor trailers).
9. All vendors must be completely set up by 2:00 pm on the day of the event.
10. **No vendor is to break down until the end of the event or otherwise communicated by event officials. NO EXCEPTIONS.**
