### A. Approval of New Community Market Agreement

Mr. Rakow, Golden Gate Community Market owner provided an overview of business operations noting:

- He will be responsible for maintaining cleanliness of the parking lot.
- The Agreement dated January 30, 2016 through January 28, 2017 will be presented to the Board of County Commissioners at the January 26, 2016 meeting for consideration.
