MEMORIAL PROGRAM

Our memorial program allows your loved one's memory to live on in an act of service to our county parks. Your contribution will be a great enhancement to our community's quality of life.

Memorial Bench Program

Memorial benches add beauty to a park as well as provide a useful amenity for park visitors to enjoy as they relax and enjoy their surroundings.

- **What is Included?**

The cost for a 6 foot bench is \$2,000.00. Cost includes the bench, memorial bronze plaque, and installation. Please allow up to 8 weeks for installation after initial purchase. You will be notified of the date for installation.

- **Bench Warranty:**

The warranty on a memorial bench with plaque will be based on its replacement life cycle of 15 years. The plaque & bench will be maintained by Parks and Recreation as long as the bench remains in place. In the event that the plaque or bench are damaged by theft, vandalism or weather, there is no obligation on the part of the Parks and Recreation Division to repair or replace. The donor will be notified and may elect to replace or repair the plaque/bench at their expense.

- **Bench Location:**

Due to the popularity of this program, bench sites are only available at the following park and preserve locations:

Freedom Park, Gordon River Greenway Park, Eagle Lakes Community Park, East Naples Community Park, Veterans Community Park, Vineyards Community Park, North Collier Regional Park, Margood Harbor Park, Caxambas Boat Park, Cocohatchee River Park, Isles of Capri Paddlecraft Park, Bayview Boat Park, Ann Olesky Park, Immokalee Community Park and selected Neighborhood Parks.

- **Bench/Plaque Specification:**

Bench is 6 feet long with a back rest.

Plaque area is 8"Wx5"H. The bronze plaque will hold up to 7 lines with 40 characters, including spaces, per line. Suggested wording must be submitted to the Parks & Recreation Department for approval. A proof will be e-mailed to the donor and the donor must sign off as to the accuracy and spelling of content. Once the signed proof is received, the plaque will go into production. Plaques require a 4 to 5-week lead time for manufacture and shipping.

Removal and/or Relocation of a Memorial Bench:

In the event that a memorial bench needs to be removed or relocated due to park construction or renovation you will be notified.
